A. October 26, 2011 minutes and project actions were approved by a 4-0 vote (Chappelle recused).

B. **New Projects.**

1. **Big Bamboo Pottery Kilns, 1251 9th Street, File Number 112-009-DR.** Project proposes to develop a pottery studio on the light industrial zoned property. Project involves: installation of two kilns (one gas, one electric) on concrete pads and a propane tank; two metal canopy structures to cover the kilns; use of an existing on-site container as the pottery studio; off-street parking; security fencing; and landscaping. Project would be located on a western portion of the property that contains the California Central Creameries Plant, commonly known as the Creamery Building, which is a designated Landmark Historic Structure (File # LHP-89-05). The project site is not located within a Neighborhood Conservation Area.

ON A MOTION MADE BY COMMISSIONER LOWRY, SECONDED BY CHAPPELLE AND A 5-0 VOICE VOTE, THE COMMISSION CONTINUED THE PROJECT TO A FUTURE DATE UNTIL SUBMITTAL OF REVISED, COMPLETE APPLICATION MATERIALS TO MEET COMMISSION PROJECT RECOMMENDATIONS. SEE ACTION FOR THIS ITEM LOCATED IN THE ARCATA COMMUNITY DEVELOPMENT DEPARTMENT, File No.: 112-009-DR.

2. **Carl's Junior Signage, 4900 Valley West Boulevard, File Number 112-012-DR.** Project proposes to update signage for the Carl's Jr. restaurant located in the Valley West commercial district. Project proposes to reface the existing double-sided pole sign, and replace existing fascia signs with updated channel lettering and design.

ON A MOTION MADE BY COMMISSIONER HEARTWOOD, SECONDED BY CHAPPELLE AND A 5-0 VOICE VOTE, THE COMMISSION CONTINUED THE PROJECT AT THE APPLICANT'S REQUEST TO A FUTURE MEETING DATE WHEN REVISED APPLICATION MATERIALS ARE SUBMITTED. 
A. **LDS Demolition Permit Update.** Community Development Director Larry Oetker provided a summary of the current status of the LDS Church demolition request. The LDS have withdrawn their planning permit and have applied for a building permit to demolish the A Street meeting house. Director Oetker revised the department's anticipated issuance date for a building permit for demolition to a date after November 17, 2011. Director Oetker explained that an appeal could be filed with the department before November 17, 2011. This item was a status update intended to inform the Historic and Design Review Commission and the public of the project's status.
